INFORMATION FROM THE HEALTH OFFICE

Physicals:

• As of July 1, 2018 New York State law requires a health examination for all students entering the school district for the first time and when entering 9th and 11th grade. Freshmen and new entrants to the Horseheads District need a physical dated on or after September 5, 2017. Juniors need a physical dated on or after September 6, 2017.

Screenings:

- New York State requires Juniors to have vision and hearing screenings either by their medical provider or the school nurse.
- As of July 2018, Freshmen boys are screened for scoliosis.

Sports:

- Family ID winter sports registration opens on October 5th.
- Winter sports tryouts begin on November 5th.
- To be eligible for your sport a current physical (dated on or after November 1, 2017) is needed.
