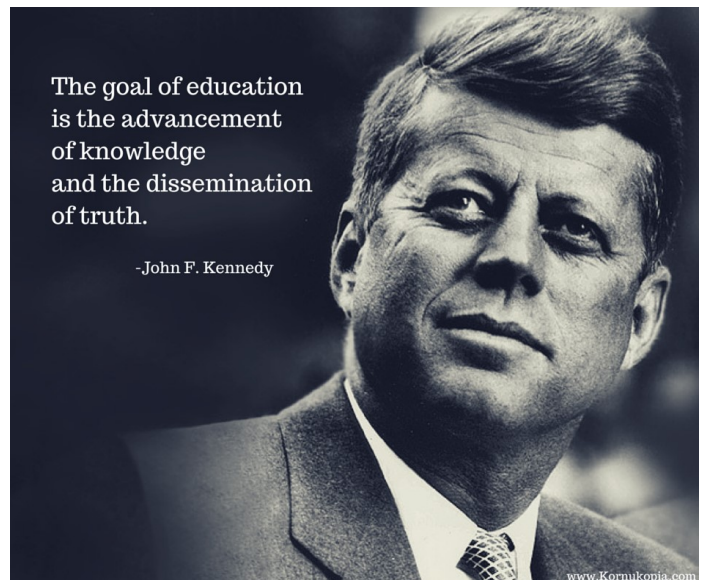
We are here to help each other!

### Notes from the Nurse

All **prescription medications** and **over-the-counter medications** require a medication administration order form from a physician and a parent signature. The parent or guardian must bring the medication in the original container to the health office. Students may not carry any medication (prescribed or over-the-counter) with the exception of inhalers, epi-pens and diabetic medical supplies.

All 7th Graders and new entrants are required to have a Physical and Dental Certificate. This is a state mandate.

School appraisals/physicals will not be completed due to COVID-19. Please contact your own provider. We encourage parents/guardians to use their own provider to monitor ongoing problems and provide medical consistency.

New York state now requires all schools to request dental health certificates from parents at the same time we require a health certificate (in grades K, 2, 4, 7 and 10).

# A Parent's Guide to Horseheads Middle School

## *What You Need to Know About School Safety & Security*



**“S**chool safety is the job of the entire school community. This effort requires leadership and coordination by school administration and involvement and participation from all sectors of the school community. Planning, conducting drills and participating in exercises with law enforcement, fire, emergency officials and other members of the school community ensures a comprehensive, unified approach to school emergency response planning. Building relationships and community engagement are vital to building a safer school community.”

Horseheads Middle School adheres to the comprehensive safety plan developed by New York State designed to help school districts prepare and plan for varied emergency circumstances. Advance planning with emergency responders in our district ensures that we are ready to provide the correct, timely response that may be needed.

Students are drilled on procedures and policies throughout the school year. Along with the usual fire drills, there will be practice with emergency drills such as for hold-in-place, lock out and lockdown in the event of an emergency occurring inside or outside of the building. Students are educated in the procedures for these drills; their knowledge of the plan allows them to perform these drills calmly and orderly. Also, our School Resource Officer (SRO) maintains an office at the middle school.

### **Parents' Bill of Rights for Data Privacy and Security**

1. The parent/guardian or eligible student has a right to:
2. inspect and review the student's education records;
3. request that records be amended to ensure that they are not inaccurate, misleading, or otherwise in violation of the student's privacy rights;
4. consent to disclosure of personally identifiable information contained in the student's education records, except to the extent that the Family Educational Rights and Privacy Act (FERPA) authorizes disclosure without consent; and
5. file a complaint with the United States Department of Education alleging failure of the district to comply with FERPA and its regulations. Complaints may be sent to Family Policy Compliance Office, U.S. Department of Education, 600 Independence Avenue SW, Washington, DC 20202-4605.

# MIDDLE SCHOOL SAFETY AND SECURITY

Safety for our students, staff, and community is a top priority. Visitation to the middle school is very limited. All visitors should come to the main entrance and press a buzzer to alert the Main Office. Visitors will state their purpose for being at the school, and must be let in by the school's Main Office secretaries. If dropping off an item for a student, the item must be left on a cart in the lobby with the student's name.

## Reporting Potential Safety Concerns

We provide a safe and confidential way for Middle School students or their parents to report threats of violence, suicide and any illegal activity that could harm students in our school. Information will go directly to the attention of Administration. Each report will be handled and confidentiality maintained. All students will be assigned a gaggle account.

### HMS Emergency Response Plan

The Horseheads Middle School Building Safety Team has created a multi-faceted response plan for potentially dangerous situations. Our plan is aligned with The Horseheads School District Safety Plan and is developed with the latest information related to school safety. Our teams are trained and committed to ensuring students and staff remain safe at school. Cooperating with local first responders is essential for building safety. 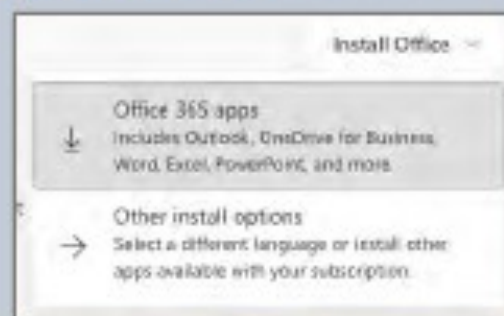
## Dear Techie Tom

# A Student's Guide to Device Maintenance Tips



## Power Saving Tips

**TIP:** Turn off your device when you are not using it. **WHY:** It will stay charged longer!

**TIP:** Turn off your device before charging it in the cart. **WHY:** It will charge faster. and **WHY:** It will get hot if left on which may damage the device.

**TIP:** Check for the light to blink once when putting the device in the cart for charging. **WHY:** The light lets you know the charger is connected.



## Web Browser Tips

**TIP:** Use Chrome first, especially for Schoology - Use Edge as a backup. **DO NOT USE:** Internet Explorer. Microsoft is abandoning development on it.



## File Saving Tips

**TIP:** Save your files to your OneDrive. **DON'T** save them directly to your device. **WHY:** If your device needs to be fixed. Your files may get erased. If they are saved to your OneDrive you can access them from anywhere.

**TIP:** When connecting to your OneDrive use your lastname-firstname@gstbores.org to login (this will work for all GST districts).



## Windows Update Tips

**TIP:** Windows updates are pushed twice a month - If you see a notification about a restart or a small green square in the right of the bottom taskbar, please restart your device. **WHY:** Updates help your device run better and correct bugs/glitches.



## Other Issues or Problem Tips

**BEST TIP:** If your device isn't working properly - try **RESTARTING** it.

**ANOTHER TIP:** Let your current teacher/staff member know what is happening.

**FINAL TIP:** Contact the IT or Tech Services Office. They are there to help.

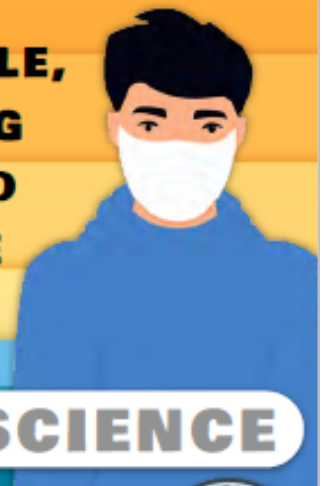

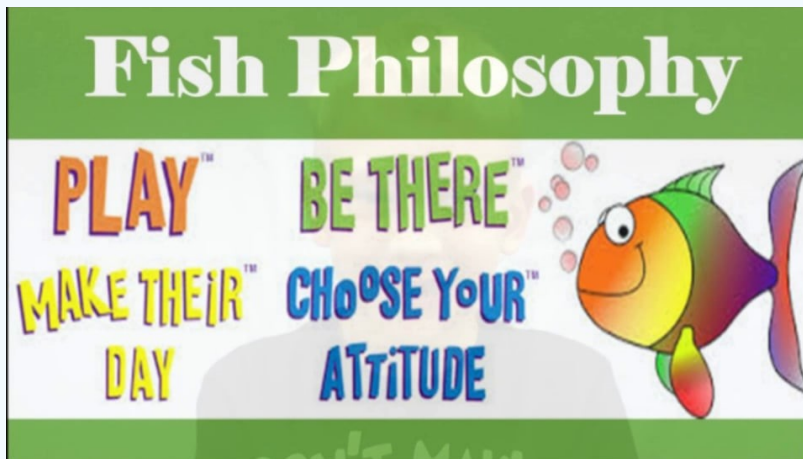

## The "Fish"monger's Philosophy

What's a fishmonger, you ask? A person who sells fish of course! In 1930s Seattle, Washington, a fish-market stall opened at the Pike Place Market. The Pike Place Fish Company served its customers well for decades. When former employee, now owner, John Yokoyama, began to stir the pot, he found a better way for his employees to enjoy their job. The fish market became one of Seattle's top tourist attractions. How did this happen? Fish Philosophy, of course.

The workers there found that four basic principles were their key to success:

***Be there in the moment (for their customers)***

***Play (by putting on a show)***

***Make their day (involving the customers)***

***Choose your attitude (how do you want to feel?)***

## **Dignity For All Students Act**

### **New York State's Dignity for All Students Act (The Dignity Act)**

seeks to provide the State's public elementary and secondary school students with a safe and supportive environment free from discrimination, intimidation, taunting, harassment, and bullying on school property, a school bus and/or at a school function.

The Horseheads School District Code of Conduct describes harassment as follows:

**"Harassment" and/or "bullying" means an intentional act against any student, on school property or at a school function, that creates a hostile environment by conduct, with or without physical contact by verbal threats, intimidation or abuse, including cyberbullying of such a severe nature that it:**

- **has or would have the effect of unreasonably and substantially interfering with a student's educational performance, opportunities or benefits, or mental, emotional or physical well-being; or**
- **reasonably causes or would reasonably be expected to cause a student to fear for his or her physical safety.**
- **reasonably causes or would reasonably be expected to cause physical injury or emotional harm to a student; or**
- **occurs off school property and creates or would foreseeably create a risk of substantial disruption within the school environment, where it is foreseeable that the conduct, threats, intimidation or abuse might reach school property.**

**"Emotional Harm" that takes place in the context of harassment or bullying shall be defined as harm to a student's emotional well-being through creation of a hostile school environment that is so severe or pervasive as to unreasonably and substantially interfere with a student's education. Such conduct shall include, but is not limited to, acts based on a person's actual or perceived race, color, weight, national origin, ethnic group, religion, religious practice, disability, sexual orientation, gender or sex.**

## DIGNITY FOR ALL STUDENTS ACT



Acts of harassment and bullying shall include, but not be limited to, those acts based upon a person's actual or perceived race, color, weight, national origin, ethnic group, religion, religious practice, disability, sexual orientation, gender or sex.

At Horseheads Middle School, harassment is not tolerated. Section B of the Prohibited Student Conduct, as listed in the Student Handbook's Code of Conduct, students are subject to disciplinary sanctions. Students will not engage in any conduct that endangers the safety, morals and health and welfare of others.

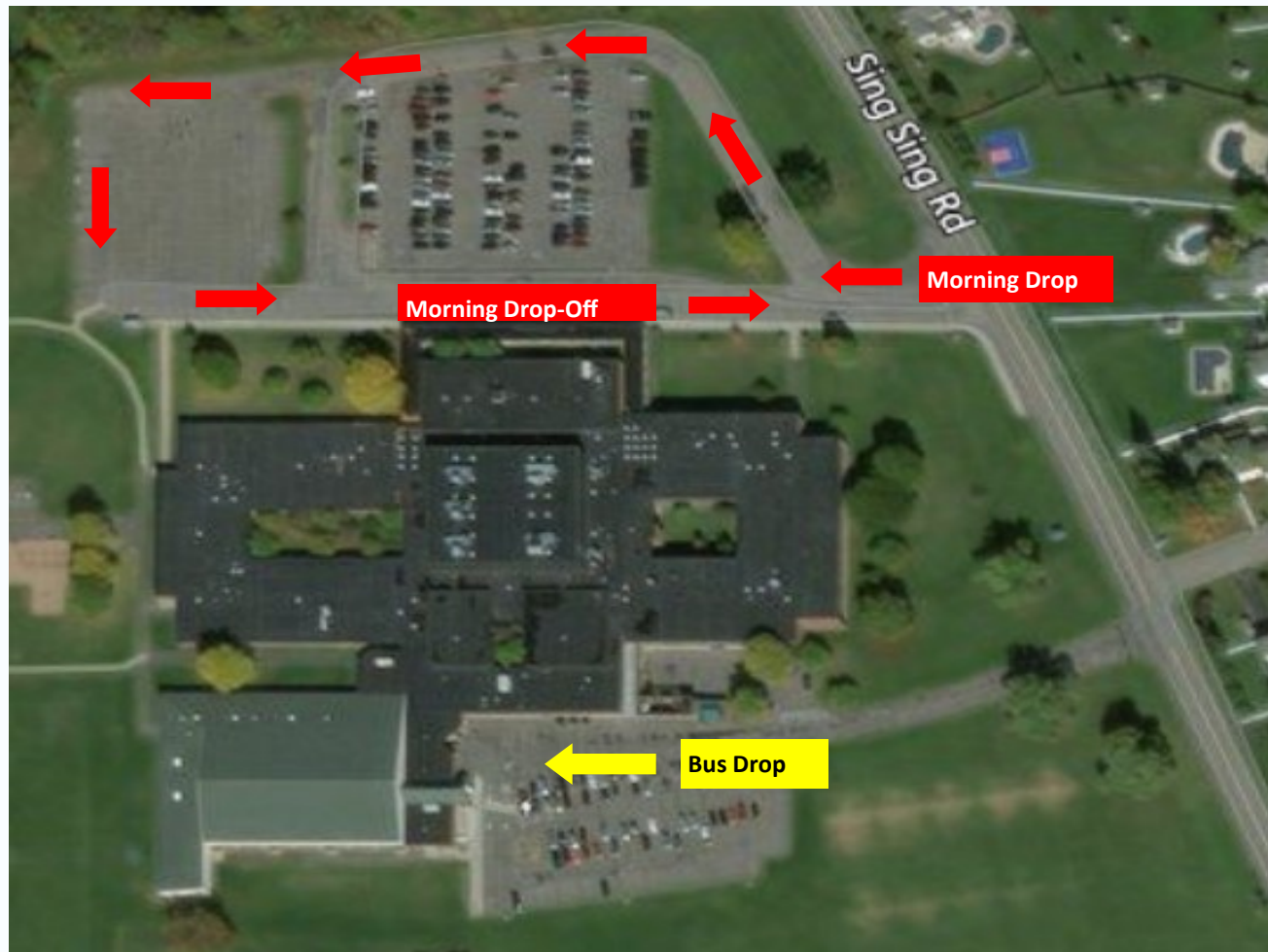
# Parking Lot Safety

**Due to the large volume of students being dropped off in the morning, the drop-off line can become very long. We ask that you help alleviate unnecessary wait time by following these simple procedures:**

- Utilize the entire drop-off lane. Please do not wait until you have pulled up to the Middle School main entrance to drop off your students. Approximately 10 cars can drop off students simultaneously. Please stay in line.
- Students should exit the vehicle as soon as it is safely stopped. Please be sure students have all of their belongings ready to go.
- **Do not drop students off on the road.**
- Students should be exiting the car no later than 7:40. This will allow them to arrive in their 1st period class by the 7:45 tardy bell. Drop off early; the closer to 7:40 you get, the more traffic you will experience.

**Thank you for your patience and helping our morning drop off go as safely and efficiently as possible.**

**Note that there is only one driveway into the parking lot, and one driveway out of the parking lot.**







### **Information about Emergency School Closings and Delays**

Schools are closed when the weather makes it impossible to have reasonable attendance or when the schools or vehicles would not be able to operate safely. The school day is delayed when inclement weather conditions improve by early morning. Inclement weather may include snow, ice, and freezing temperatures. If the school day is delayed, buses will run and schools will open two hours later than the usual time.
