Please see the following important items of information:

Masks

On Monday, Governor Cuomo updated mask requirements in the state to meet the Centers for Disease Control's new guidelines. These guidelines went into effect yesterday, allowing fully vaccinated individuals to go unmasked in certain situations. Please note this change does not apply to schools, public transportation, nursing homes, health care facilities, or other locations noted in the guidelines. **The district will continue to require mask use in buildings, on school grounds, and on school transportation**.

Voluntary Vaccine Clinic for Ages 12 and Older

We are assisting the Chemung County Health Department by providing locations for COVID vaccine clinics. Last week, the district hosted a clinic at the High School. We are currently working with the Health Department on a second clinic, now that the state has expanded the eligible age group to age 12. The district is not requiring the vaccine for students or staff.

We will be sending an online survey to families with eligible students to determine if there is enough interest to hold a clinic May 27 at our Middle/Intermediate School complex with the second dose on June 18. Please note: If your child has already received the vaccine or if you do not want your child to receive the vaccine, you may disregard the survey. And again, the district does not require the vaccine for students or staff. Discounted Broadband for Eligible Households

The Federal Communications Commission (FCC) recently announced the Emergency Broadband Benefit Program, which provides a temporary discount on monthly broadband bills for eligible consumers. The application process is open now. Eligible households can receive a discount of up to \$50 per month on monthly broadband bills for eligible consumers and/or a one-time discount of up to \$100 on a laptop, tablet, or desktop computer.
